BOARD MEETING AGENDA

A regular public meeting of the ASDB Board of Directors is scheduled to begin at 5:00 p.m. on Thursday, October 24, 2013, in the Berger Performing Arts Center on the ASDB Tucson Campus, Arizona State School for the Deaf and the Blind, 1200 W. Speedway Blvd, Tucson, Arizona. It may be necessary for some Board members to participate by phone. If so, a phone with speaker capability will be available to permit persons in attendance to monitor the proceedings.

Pursuant to A.R.S. 38-431.02(H), the Board may discuss, consider and take action concerning any matter listed on the agenda and other related matters.

- II. Public Comment on Agenda and Non-Agenda Items**

This is the time for the public to comment on agenda and non-agenda items. Therefore, pursuant to A.R.S. 38-431.01(H), a public body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

Unless modified by the President at a particular meeting, due to circumstances on that occasion, each speaker is limited to three (3) minutes.
