Pursuant to A.R.S. 38-431.02, notice is hereby given to the Board of Directors of the Arizona State Schools for the Deaf and the Blind and to the general public that the Board of Directors of the Arizona State Schools for the Deaf and the Blind will hold a meeting open to the public on **Thursday, September 10, 2015 at 4:00 p.m.** at the **ASDB Tucson Campus, 1200 W. Speedway Blvd., Berger Performing Arts Center, Tucson, Arizona.** The Board reserves the right to change the order of items on the agenda, with the exception of public hearings set for a specific time.

Pursuant to A.R.S. 38-431.02(H), the Board may discuss, consider and take action concerning any matter listed on the agenda and other related matters.

Pursuant to A.R.S. 38-431.03(A)(1), the Board of Directors may vote to go into executive session, which will not be open to the public, for the purposes of discussion and consideration of employment matters as it relates to agenda items.

Pursuant to A.R.S. 38-431.03(A)(2), the Board may vote to go into executive session, which will not be open to the public, for discussion or consideration of records exempt by law from public inspection, including the receipt and discussion of information or testimony that is specifically required to be maintained as confidential by state or federal law as it relates to agenda items.

Pursuant to A.R.S. 38-431.03(A)(3), the Board may vote to go into executive session, which will not be open to the public, for discussion/consultation for legal advice with the Board's attorneys as it relates to agenda items.
